\$80 per floor for all manufactured or modular homes shipped to a retail sales center or private site within the state of Georgia on or after September 1, 2005*.

Manufacturers are to include with their monthly dues, a copy of their HBT 302 form for the period of the dues being remitted.

Manufacturer's dues are to be remitted to the Association by the 15th of each month for the preceding month's shipments.

If a manufacturer does not have any shipments of manufactured or modular homes to a retailer or private site within the state of Georgia during any given month, a copy of that month's HBT 302 form is to be submitted to GMHA by the 15th of the following month.

Manufacturer will not be required to begin remittance of per floor dues until month following approval of application by GMHA Board of Directors.

POLITICAL ACTION COMMITTEE FUND

The Georgia Manufactured Housing Association's political involvement on behalf of the manufactured housing industry ensures that our members' interests and concerns are communicated to local, state and federal appointed and elected officials on issues related to the industry.
